# INTRODUCTION

# UCL PUBLIC AFFAIRS AND SOCIAL SERVICE



UCL PASS was established by a group of enthusiastic Hong Kong students in 2011. We aim to provide a platform for students from UCL to raise awareness of social and political issues as well as to benefit the underprivileged through involvement in social service. Our Careers branch has been established since 2014 to provide Hong Kong students with career guidance and support. We strive to establish ties with firms from various industries and organise a number of careers events, including skills sessions and firm visits, with the aim of maximizing members' exposure to career opportunities. Every year since 2014, we organise a senior-year mentorship programme for freshers to provide assistance on their transition into university. We had a successful year co-organising the mentorship programme with UCL Chinese Society last year and we look forward to another fruitful year.

# UNIVERSITY COLLEGE LONDON

#### **UCL CHINESE SOCIETY**

UCL Chinese Society (UCLCS) is one of the largest and well-established student societies within UCLU and the United Kingdom, with up to 200 new members joining per annum. As both an educational and cultural society, we aim to promote Chinese culture within UCL and beyond, while offering students with a Chinese background a 'second home' during their time at university. The Metis Association was founded in 2013 and it collaborates closely with UCLCS. Our predominant project is to organise and promote a mentorship programme that would link UCL undergraduates with career professionals who are UCL Alumni. Apart from the mentorship programme, Metis Association also organises social events for all UCL students.

# MENTORSHIP PROGRAMME

Jointly organised by UCL PASS and UCL Chinese Society, as well as being supported by the UCL Hong Kong Club, the programme links current students to UCL alumni to develop a meaningful relationship which would benefit students throughout their university life and beyond. The programme also allows students to gain useful insights and advice into the career paths they aspire towards. We have a wide range of mentors who can share their experiences in their profession to their student mentees.

The programme will begin with a meet-and-greet session during the winter holidays, with the aim of fostering a continued mentor-mentee relationship.

# PROGRAMME OVERVIEW

#### **INTRODUCTORY SESSION**

A compulsory introductory session for mentees. The aim of this session is to provide the mentees with details regarding the mentorship programme. We will explain the importance of being a good mentee and some techniques on building a rapport with the mentors. Mentees will be arranged into groups by mentor. Between the introduction session and the meet-and-greet session, mentees are expected to contact their respective mentors.

#### **MEET-AND-GREET SESSION**

Mentees will meet their mentors at the meet-and-greet session in early January. After the meet-and greet, mentees are expected to keep in contact and initiate summer meetings with their mentors.v



# **GUIDELINES FOR MENTEES**

#### **BEFORE THE MEETINGS**

- Prepare an updated CV and set up a LinkedIn account (if you haven't yet)
- Always reply your mentor's messages in a prompt and polite manner
- Research your mentor, the company he/she works at to leave a good impression to your mentor

#### **DURING THE MEETINGS**

- Prepare plenty of questions for your mentor
- Share your goals, enthusiasm and curiosity with your mentor, ranging from challenges at work to daily
- Be confident to express your thoughts and ask many

#### AFTER THE MEETINGS

- Express your gratitude by sending a thank-you letter
- Schedule mutually agreeable times and meeting format with your mentor, and respond promptly
- Keep in contact with your mentor beyond official mentorship period
